Re: Notice of Improvement

In accordance with the publication *Successful Schools and Achieving Students 2* by the Office of Education Standards (OES) and the expectations of the Ministry of Education (MOE) and the Education Council (the "**Council**"), all schools in the Cayman Islands are expected to receive a minimum judgement of "*Satisfactory*" in their OES inspections. All key aspects of performance and practice in every school should meet or exceed this level.

As a result of Wesleyan Christian Academy receiving a judgement of "*Weak*" by the OES from your full inspection in September 2022, and the Council receiving a Notice of Concern from the OES in relation to that judgement, the Council, at their meeting on 17 November 2022, has taken the decision to issue Wesleyan Christian Academy with a Notice of Improvement (the "**Notice**").

The Notice is being applied under Section 11(2)(b)(i) of the Education Regulations, 2017 which states:

(2) Where –

(b) the educational institution or institution providing educational support services is found to be in arrears with inspections or not in compliance with requirements of good governance or health and safety agencies the Education Council may –

(i) by notice in writing, give the educational institution or institution providing educational support services a timeline to remedy the concern specified in the notice;

By receiving a judgement of "*Weak*", the Council considers this non-compliance with the requirements of good governance as it is the responsibility of the school leadership to ensure the respective school meets the quality assurance requirements.

The Council is therefore requiring Wesleyan Christian Academy to obtain at least a judgement of "*Satisfactory*" progress in all recommendations issued by the OES in your next Follow-Through Inspection and at least an overall judgement of "*Satisfactory*" in your next Full Inspection or the Council may proceed with Section 11 (2)(b)(ii) or (iii) of the Education Regulations, 2017 which states:

Section 11 (2)(b)(ii): suspend the registration of the educational institution or institution providing educational support services and direct that no person is to attend the educational institution or institution providing educational support services until the concern specified in the Education Council's notice is remedied and a favourable inspection report submitted to the Ministry; or

Section 11 (2)(b)(iii): cancel the registration of the educational institution or institution providing educational support services and immediately cause no person to attend the educational institution or institution providing educational support services.

When Wesleyan Christian Academy is informed of the dates of their next inspections by the OES, this information must be sent to Education Strategy Officer, Mrs. Kimberly Kirkconnell at kimberly.kirkconnell@gov.ky. Once a judgement is received, Mrs. Kirkconnell should also be informed of this so that the Council can be updated to determine further action as necessary.

Attached to this letter is the Notice of Improvement Certificate which must be displayed publically on the school's premises at all times and on the school's official website. Please be advised that this letter should be made available to any person or organisation who wishes to view it.
